Be Inspired.

IT IS HEREBY AGREED on this date of March, 17, by and between the Village of Barrington, and Charlie and Rob Knapik,(Sons of Bildor), for and in consideration of the mutual covenants contained herein that:

1. The Entertainer shall perform for the Village of Barrington under the following agreement:

Date: September 12, 2026

Time/sets: 2:00 PM – 5:00 PM

(3-hour performance; 3 sets with 15-minute breaks)

Location: Downtown Barrington – outdoor parking lot event space

Purpose: Provide live music to enhance the Brew and Browse event experience.

Sound Reinforcement: Provided by event organizers; includes PA system, microphones, and speakers. Entertainers provide instruments.

2. The Village of Barrington shall pay to the Entertainer the sum of \$700 or said performance(s) described in Paragraph 1 hereof, which shall be the Entertainers sole compensation.
3. The Entertainer may provide equipment, props, and other paraphernalia necessary for said performance(s) at Entertainer's sole expense and all such items shall be removed from the premises immediately after said performance(s) is/are complete. The Village of Barrington shall have no responsibility for damage to such items unless caused by their own negligence.
4. The Entertainer is responsible for communicating sound production requirements to the Village of Barrington. Since each event requires different sound production arrangements, these arrangements are as follows, unless clarified below. The entertainer shall provide limited sound support including instruments, amplifiers, and specialty equipment as needed, while the event organizer will provide microphones, speakers, and a basic PA system. It is noted that the following outdoor tented performance setup in a parking lot space with access to standard electrical outlets and minimal lighting is required for this performance as it relates to sound, lighting, and the stage performance.
5. The Entertainer agrees to defend, save and hold harmless the Village of Barrington and any of its agents and officials from any and all liability, claims, damages or injuries of any nature whatsoever caused in whole or in part by the Entertainer pursuant to this agreement.
6. In the event of a Force Majeure as outlined below, the Village of Barrington agrees to pay the Entertainer in full. Force Majeure includes: acts of God (including severe weather such as storms, flooding, or extreme temperatures), emergency situations affecting the safety of attendees, fire, natural disasters, government orders or restrictions, public health emergencies, labor strikes, power outages, and acts or threats of terrorism.
7. The forgoing provisions, terms and conditions constitute the entire agreement between the parties hereto, and such terms and conditions may be modified only by a written agreement between the parties hereto:
